#### 5. **RESERVATION:**

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 4% for PwBD candidates (on horizontal basis).
- **For OBC-NCL Candidates:** Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application.

  - Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
  - Dimensions 200 x 230 pixels (preferred)
  - Size of file should be between 80 kb–100 kb
