2. The applications received after these dates will not be entertained. The University shall not be responsible for delay in receipt of applications due to any reasons what so ever.
3. The candidates must ensure their eligibility in respect of category, essential qualification(s) etc. as mentioned against concerned post in the advertisement to avoid rejection at later stage.
4. The candidates, who wish to apply for more than one post, should apply separately for each post and will have to pay the requisite fees for each post in the prescribed manners.
