Thereafter, out of total candidates who will qualify the written examination, the number of candidates as decided by the Selection Committee will be called for Computer Proficiency Test (CPT) i.e. to assess the proficiency of candidates in operation of computer, which is mandatory, however, the marks of this Computer Proficiency Test would not be counted in determining the final merit as this test is only qualifying in nature.

Computer Proficiency Test shall comprise of two parts.



In Part-I, candidates will have to qualify Spread Sheet Test which is of 10 marks and of 10 minutes duration, by securing 4% or more i.e. 4 or more marks.

In Part-II, candidates will have to qualify Computer Typing Test in English at the speed of 30 W.P.M.

Thereafter, Select List of the qualified candidates will be prepared strictly on the basis of merit.
