1. The AIIMS, Vijaypur, Jammu reserves the rights to increase or decrease or not to fill up any post(s) without assigning any reason. The Competent Authority reserves the right to amend, cancel or change this advertisement as a whole or in part without assigning any reason or giving notice.
2. The posts are whole time and private practice of any kind is strictly prohibited.
3. All posts carry usual allowances as admissible to Central Government Employees of similar status at Samba (Vijaypur) UT of J&K.
4. Applicants must possess the essential qualification and experience up-to-the last date of online submission of application(s). Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is/are not genuine.
5. **SELECTION PROCESS:** Selection is based on performance in the Interview. However, written test or screening, based on objective criteria may be done to shortlist applicants to be called for interview. The decision of the Competent Authority regarding shortlisting of candidates to be called for interview, would be final and binding on all candidates.
6. **MODE OF INTERVIEW:** For interview, a candidate has to appear *in person*. No request for an online interview i.e., through electronic media will be accepted and no correspondence in this regard will be entertained.
7. Canvassing of any kind will be a disqualification.
8. The candidate should not have been convicted by any Court of Law.
9. All disputes will be subject to jurisdiction of Court of Law at Jammu UT of J&K.

#### 11. ELIGIBILITY NORMS:

- a) The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of Online applications i.e. should have passed qualifying exam for essential educational qualification / have completed duration of experience as given in Recruitment rules on or before last date of online submission of form. In those cases where one passes exam or complete duration of experience after this date, their candidature will stand cancelled.
- b) Candidates must upload the documents/certificates in support of all the claims made by them in the application like, Date of Birth, Experience (in sequence as mentioned in application), Essential qualification(s), Caste certificate/EWS certificate/Disability proof or any other information as applicable in their case, separately against each claim. Each document should be uploaded in PDF/JPEG format, as required in online application. File size should not exceed the prescribed limit. Print out of all such file should be legible when printouts are taken. For this purpose, the applicant should scan the documents/certificates in 200 dpi grey scale. Documents which have not been asked for like Pay Slip, Resume, Appointment letter, Relieving letter, Un-signed Experience Certificate etc. must not be uploaded in Document upload module.
- c) Matriculation/10<sup>th</sup> Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10<sup>th</sup> Standard or equivalent issued by Central /State Board indicating Date of Birth should be submitted in support of claim of age.
- d) **Education Qualification certificates:** as per Recruitment Rules for the post applied must be uploaded. In case of those who have equivalent educational qualification, Order/ letter regarding equivalent Educational Qualification claimed, indicating the Authority (with number and date) under which it has been so treated, regarding equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement. The equivalent qualification will be decided by the Competent Authority of AIIMS, Jammu and his decision will be final in this regard.
- e) **Experience Certificate:** should be from the Head(s) of Organization (for the period of experience claimed, clearly showing the, duration of experience ("from" to "to"), Nature of experience (either teaching and/or research). Teaching / research experiences which are gained in organization recognized by MCI/NMC/UGC recognized teaching institutions will only be considered. Experience acquired after having acquired requisite essential qualification for the applied post will only be considered to determine eligibility as per recruitment rule for the post.
- f) **DNB equivalence:** In cases of those who are holding DNB in broad specialties or super specialty as essential qualifying education, they have to produce documentary evidence issued by Competent authority about DNB equivalence with MD/MS/DM/M.Ch as per NMC New Delhi notification dated 14.02.2022. (The Diplomat of National Board (DNB) in broad specialty and super specialty qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of **five hundred or more beds**, by the National Board of Examinations, shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/MCh) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purpose of teaching.)
- g) **SC/ST/OBC/PwBD/EWS Certificate:** Candidates applying for any of the reserved category posts, viz. SC/ST/OBC/PwBD/EWS will be considered subject to Caste/PwBD/EWS certificate issued by the appropriate/Competent Authority in the prescribed format. Community should be clearly and legibly mentioned in the Certificate.
- h) **OBC Candidates:** Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoPT vide O.M. No.36036/2/2013-Estt (Res.) dated 30.05.2014 and further clarification issued by DoPT vide OM No.36036/2/2013-Estt (Res-I) dated 31.03.2016. OBC candidate's eligibility will be based on the caste(s) **borne in the Central List of Government of India**. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidature will not be considered for OBC post. They will however be treated as UR candidate (if otherwise eligible to be considered as UR, if UR post is available). The vacancies are being advertised in financial year 2025-2026, therefore, valid NCL-OBC certificate issued during the period from **01.04.2025 to 24.10.2025** will be considered valid. Candidate who submits NCL-OBC certificate issued before **01.04.2025** their certificate will be considered as invalid & their candidature as OBC certificate will stand cancelled for this recruitment. Candidates who are not having NCL-OBC certificate which has been issued during the period from **01.04.2025 to 24.10.2025** will not be considered against post reserved for OBC category under any circumstance.
- i) **PwBD Candidates:** All the above-mentioned posts are identified suitable for PwBD candidates and 4% of the total vacancies are horizontally reserved for PwBD candidates as per the Ministry of Social Justice and

Empowerment's Notification No. 16-15/2010-DD.III dated 29th July, 2013 as amended from time to time as applicable. Only those persons would be eligible for reservation under PwBD category, who have not less than 40% of disability. Any candidate who wants to avail the benefit of reservation should submit a Disability Certificate issued by a Competent Authority in prescribed format as per "Rights of Persons with Disabilities Act, 2016". The candidature of PwBD applicant is subject to evaluation by the Medical Board duly constituted by the Executive Director, AIIMS, Vijaypur Jammu. This board will evaluate suitability of candidates for the post one is being considered for.

- j) **EWS Candidates:** The vacancies advertised under EWS category will be filled as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, Vide OM No.36039/1/2019-Estt (Res) dated 31.01.2019. Applications under EWS category will be considered subject to submission of Income and Assets certificate by the applicant in the prescribed format issued by the Competent Authority and subject to verification of genuinity of the certificate by the issuing authority. As per DoPT OM No. 36039/1/2019-Estt (Res) dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidates is the closing date for receipt of application for the post. Therefore, EWS candidate must ensure that they have a valid EWS certificate issued on or before the last date of submission of application. Candidate who fail to produce valid EWS certificate issued on or before the cut-off date will not be considered for reservation under this category. They will however, be considered as UR candidate. Candidates are permitted to apply against posts earmarked for EWS subject to the conditions that their candidature will be considered only if EWS applicants are not available and that their candidature will be as UR candidates only, which means, there shall be no relaxations which are otherwise permitted under their reserved categories.
- k) **NOC Certificate:** No Objection Certificate from the present employer (in case of regular candidates working in Government/Semi or Quasi Government, Government enterprises or Government funded autonomous institutions) is mandatory. **Those who fail to produce NOC will not be allowed to appear for the interview for the post.** Therefore, candidates are advised to upload NOC along with application or alternatively must produce it at the time of interview failing which he/she shall not be interviewed. Candidates, who are working as contractual employee in Government/Semi-Government/PSUs/Autonomous Bodies or any institution funded by Government, also have to produce NOC mandatorily. In case of change in employment status on or before interview/selection process due to any reasons, they have to take fresh permission from their new employer before interview and they also have to submit fresh NOC from their new employer.
- l) **Application for more than one post:** In case a candidate wishes to apply for more than one post, he/she is required to fill in the form separately for each post through On-line mode and deposit application fees separately along with each application.

- n) **Failure to submit the hard copy by due date of submission i.e. on or before 28.10.2025 (Tuesday) will lead to cancellation of the candidature.**
- o) Applications which are not complete as required for online submission, or applications where application fee is not submitted will be rejected without any communication. Therefore, to avoid rejection of their application, candidates are requested to make sure that application fee is paid, application is complete in all respect before they finally submit/upload the application.
- p) **Document Verification:** All the original certificates/documents will be verified at the time of interview. The shortlisted candidate(s) who are called for interview should bring print out of online application, a set of self-attested photocopy of all documents uploaded online along with Original certificates/documents. (i) 10<sup>th</sup> class, (ii) essential educational qualifications and experience certificate/s, (iii) Caste/EWS/PwBD certificate as applicable. Failure to produce these certificates/documents on the day of verification of documents/interview will lead to cancellation of candidature and candidate will not be allowed to appear for interview. - iv. Certificate of Registration with Medical Council of India, whichever is applicable.
- v. Certificate of belonging to SC/ST/OBC/EWS/PwBD category wherever applicable in the prescribed format issued by Competent/appropriate authority.
- vi. Experience Certificate showing that you have possessed the requisite number of years of teaching and/or research experience on last date of online application as prescribed for each post, from MCI/other recognized Institution(s) as applicable, subject to following:
  1. Teaching/Research experience acquired only after post graduate qualification/Ph.D. as applicable in the specialty will be considered.
  2. Those who have DNB as qualifying degree, will need to have 1-year extra experience i.e. total 4 years from MCI recognized/permitted institution for equivalence if the bed strength of institution or hospital where one did DNB training is less than five hundred (500).

Teaching experience to be counted for the applied post, should be in the concerned specialty from NMC/MCI recognized medical college (in cases where NMC/MCI recognition is from a particular year, experience prior to that will not be considered). Likewise, Post Graduate experience acquired in NMC/MCI recognized institution (recognized for MBBS course or if only award PG degree, then NMC should have recognized PG course in the specialty where he/she acquired experience) will only be considered valid.

13. **PROBATION:** Period of probation for all faculty posts is two years.
14. The employees of the AIIMS will be governed by the New Pension Scheme as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECB & PR Division) Notification No. 5/7/2003-ECB&PR dated 22.12.2003.
15. **JOINING TIME** will be 30 days from the issue of appointment letter. Extension in joining time will be considered, only in exceptional cases, with the approval of Competent Authority, AIIMS, Jammu. If one is selected / offered against more than one post, when he/she joins against offered post & opts to change, he/she will not be allowed to change
16. **STUDY COURSE:** Candidate who is pursuing any program e.g. M.Ch./DM/Fellowships etc. while applying the post, he/she shall be allowed to join only if he/she has completed the course on or before the last date of joining given in the offer letter. No request to allow to join as faculty and continue to pursue the course will be considered. Any request for extension in joining time to complete such course will summarily rejected.
17. **RESIDENTIAL ACCOMMODATION** There is provision of providing residential accommodation to the faculty appointed at the AIIMS. However, in view of the paucity of the residential accommodation in the campus, it may not be possible to provide accommodation soon after joining. In the event that no accommodation is provided, necessary House Rent Allowance (H.R.A) as admissible to the Central Government Servants of similar status stationed at Vijaypur (Samba/ UT of J&K) will be provided as per rules.
18. **MAXIMUM AGE-LIMIT AND AGE RELAXATION:**
  - a) 50 (Fifty) years for all posts as on last date of online application form.
  - b) Cutoff date for determining eligibility in terms of age shall be the last date of submission of Online applications.
  - c) No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies or if SC/ST/OBC candidates are considered against UR post on merit. The age concession to the PwBD shall be admissible irrespective of the fact whether the post is reserved for PwBD or not.
  - d) Age relaxation permissible to various categories is as under:

Age relaxation will not be applicable to those working under Autonomous Body/State Government/PSU.
