- 4. Submission of filled application form shall commence from date of advertisement and will close at 1700h on 15 Dec 2025.
- 5. Eligibility Criteria.
 - 5.1 **Direct Entry Havildar**. Terms and Conditions for Enrolment as Direct Entry Havildars. The broad terms and conditions as applicable to these personnel are given in the succeeding paragraphs:-

- 6. **Marital Status**. Only unmarried male and female candidates will be eligible for enrolment as Direct Entry Havildar and Naib Subedar (Sports).
- 7. **Selection Criteria**. Deserving candidates would be called to appear for trials at designated Army Centres. The candidates qualifying physical fitness test, physical Standards test and skill test will undergo medical examination at trials site itself. The offer of enrolment will be forwarded to the selected candidates only, which will be strictly determined by requirement in particular sports disciplines and availability of vacancies. Request for change of venue of selection trials will not be entertained.

- 10. Physical Standards (Female).
 - 10.1 **Height**. 162 Cms
 - 10.2 **Weight**. Proportionate to height and age as per Army Medical Standards.
 - 10.3 **Chest Expansion**. The candidate should be capable of chest expansion of 05 Cms.
 - 10.4 **Special relaxation for height**. Candidates belonging to following regions will be given 4 cms height relaxation:-

Note:- Waiver in physical standards and tests for both male and female can be given for exceptional talent.

12. Mandatory Medical Standards

- 12.1 Medical examination of candidates who qualify in Physical Fitness Test, Physical Standards Test & Skill Test will be conducted by Army Medical Team at the trials site as per Army Medical standards and policy in vogue on the subject issue.
- 12.2 Unfit candidates will be referred to MH for specialist review. Candidates to report designated Military Hospital within 05 days from referral and review medical exam to be completed by Military Hospital within 07 days as per policy.
- 12.3 The recruitment medical officer and the specialist doctors of Armed Forces are the final authorities on declaring a candidate fit or unfit during initial med examination, review medical examination and med examination prior to enrolment. The candidates shall be governed by Army standards which may be at variance from civil standards. There is no provision for representation or appeal or re-review after the review medical examination.
- 12.4 Passing in the medical examination is not a guarantee for employment in Indian Army.
- 13. Consumption of Narcotic Drugs and Psychotropic Substance (NDPS). Consumption of Narcotic Drugs and Psychotropic substances banned under the NDPS Act 1985 shall be rejection criteria for selection into the IA. Direct Entry Havildar and Naib Subedar found either in possession or storing or distributing or consuming such drugs and substances after enrolment shall be liable for disciplinary action including dismissal from the IA. ZERO TOLERANCE POLICY TO ALCOHOLISM AND SUBSTANCE ABUSE IS FOLLOWED IN IA.
- 14. **Body Tattoos**. Permanent body tattoos are permitted, however, tattoos only on inner face of the fore arms (inside of elbow to the wrist), back (dorsal) part of the hand/reverse side of the palm and Tribal with tattoo which are as per the custom and traditions of their tribes may be considered. Offensive, obscene, indecent, sexist or racist tattoos are prohibited regardless of location on the body. However, right to consider a tattoo acceptable or unacceptable will rest with the selection centre. Candidates with permanent body tattoos are to submit two Postcard size photographs (close up and distant view) with details of size and type of the Tattoo during the recruitment trial.
- 15. **Only Sikh candidates.** Whose religion prohibits cutting of hair or shaving of face, shall be permitted to grow hair and/or retain beard and moustache. Accordingly, those Sikh candidates willing to retain the same as per laid down specification are to get their photographs with beard and moustache.

16. Pay & Allowances/ Pension.

- 16.1 **Pay and Allowances**. Pay & allowances for direct entry Havildar and Naib Subedar shall be same as applicable to existing Regular Serving Personnel of Indian Army as per provision of Army pay Rules, 2017 and amendments thereon.
- 16.2 **Pension**. Pensionary benefits will be governed as per the extant provisions contained in Pension Regulations for the Army -2008 and amended from time to time.
- 16.3 **Other Benefits**. All other benefits viz. CSD, medical facilities etc shall be applicable to them, as existing for Regular Serving Personnel of Indian Army and amendments from time to time.

- 17. **Insurance cover**. Insurance cover and deduction of premium will be applicable as per existing norms applicable for Regular Serving Personnel of Indian Army.
- 18. **Promotion and Prerequisites**. Promotion prospects exist based on merit up to the rank of **Sub Maj**. Opportunities for promotion to commissioned officer also exist for those who perform well, qualify the prescribed examinations/ selection process and meet the eligibility condition stipulated from time to time.

19. Post-Retirement Benefits.

- 19.1 **ESM Status**. On release from service, the personnel enrolled under this entry shall be entitled to ESM status on completion of initial term of Engagement or as per the provisions contained in ex-servicemen (re-employment in civil services and posts) Rules, 1979, as amended from time to time. ESM quota for employment in Government Jobs, availing ESM facilities of Central/ State Government etc will be applicable to DE Hav & JCOs.
- 19.2 **ECHS Facility**. Grant fo ECHS facilities to the persons enrolled under this scheme will be governed by the provisions contained in Central Organisation ECHS, AG's Br IHQ of MoD letter No B/49701-PR/AG/ECHS/2019 (as amended from time to time).
- 19.3 **CSD Facilities**. CSD facilities to such persons will be applicable as per the provision contained in AO 2/2006 QMG (amended from time to time)

20. Employability & Liability for Service.

- 20.1 Individual enrolled under this entry will be liable for service in any part of the world and assigned any duty in organisational interest, as decided from time to time by the IHQ of MoD (Army).
- 20.2 Reserve liability for as applicable to the existing JCOs/OR.

TRAINING AND INITIAL ENGAGEMENT

- 21. **Training**. The initial training for the sportsperson will be conducted at designated Regimental Centre followed by Professional training in the allotted trade in various Army Training Establishment. Branch/ Trade will be allocated as per the requirement of Service.
- 22. **Discharge as Unsuitable**. Havildar & Naib Subedar are liable to be discharged as UNSUITABLE due to unsatisfactory performance at any time during the training.
- 23. **Probationary Period**. All sportsmen enrolled under this scheme will be placed under a probationary period of 3 years. Havildar & Naib Subedar entries are liable to be discharged if sports performance does not improve to expected levels in the probationary period of three yrs.

24. Miscellaneous Issues

- 24.1 **Dress Regulations**. As applicable for Regular Serving Personnel in Indian Army both during training period and post completion of training.
- 24.2 **Travel Concessions**. As applicable for Regular Serving Personnel in Indian Army.
- 24.3 **Authorization of Clothing Items**. As applicable for Regular Serving Personnel in Indian Army as per entitlements.

- 25. Candidates discharged from Indian Air Force/Indian Navy/any other Government Organisation shall also be eligible subject to their discharge with **NO ADVERSE ENTRIES**. Such candidate has to declare at the Selection Trials venue that he is an Ex-employee of the Organisation discharged from and produce original Discharge Certificate. In case of serving individuals, they must be in possession of NOC from their employer at the time of Selection Trial. If any candidate does not disclose the fact of being employed or that of being an Ex-employee, his candidature shall be cancelled at any stage during the selection process and if selected shall be liable for discharge/dismissal for hiding the fact of his employment and discharge/dismissal from service. **Candidates discharged from Indian Army for any reason are not eligible to appear in the selection trials**.
- 26. Candidates found under influence of performance enhancing drugs/substance abuse (Dope) while participating in selection trials or any time before the date of enrolment, shall be disqualified immediately and even if caught in dope or under influence of prohibited performance enhancing drugs during the training in the training centre their candidature will be cancelled.
- 27. Candidates should be prepared to stay for the entire duration of the selection trials and medical examination at place mentioned in call letter for which they have to make their own arrangement.
- 28. Candidates not reporting for the trial on due date and time shall not be accommodated on other dates/shifts.
- 29. **Documents Required**. Candidates are to bring the following documents during attending the sports trials:-
 - 29.1 **Photograph**. Twenty(20) copies of unattested recent (taken not more than one month before, from the date of publishing of the advertisement notification) passport size colour photographs developed on good quality photographic paper in white background. **Computerized/ photocopied/ photo shopped photographs will not be accepted**. Photographs must be with proper haircut and clean shave (except Sikh candidates).

29.2 Education Certificates.

- 29.2.1 Education certificate with marks sheet of all education qualification achieved by candidate i.e Matric/Intermediate etc from recognized School/College/Board/University.
- 29.2.2 Provision /online education certificate should be certified in ink signed by the head of the education institution of concerned Board/University.
- 29.2.3 Candidates with matric certificate from open school should bring school leaving certificate countersigned by EO/DEO.
- 29.3 **Domicile Certificate**. Domicile Certificate with photograph issued by Tehsildar/ District Magistrate.
- 29.4 **Caste Certificate**. Caste certificate affixed with photograph of the candidate issued by the Tehsildar/ District Magistrate.
- 29.5 **Religion Certificate**. Religion Certificate to be issued by the Tehsildar/ SDM (if religion as "SIKH/ HINDU/ MUSLIM/ CHRISTIAN" is not mentioned in caste certificate).

- 29.6 **School Character Certificate**. School Character Certificate issued by the School/College Principal/ Headmaster where the candidates last studied.
- 29.7 **Character Certificate**. Character Certificate with photograph issued by Village Sarpanch/Municipal Corporation within last six months from the date of dispatch.
- 29.8 **Unmarried Certificate**. Unmarried Certificate for all candidates with photograph issued by Village Sarpanch/ Municipal Corporation within last six months.
- 29.9 Candidates serving/ discharged from Indian Army/ Indian Air Force/ Indian Navy/ Any other Government Organisation.
 - 29.9.1 Original and four self-attested photocopies of Discharge Certificate (as issued from Indian Air Force/Indian Navy/Government Orgnisation) Subject to no adverse entry in discharge certificate.
 - 29.9.2 NOC in original and four attested photocopies from the employer for candidates presently serving in any government organization (if applicable).
- 29.10 **Sports Kit**. Candidates to bring their own sports gear and equipment for physical fitness test and skill test.

Note. Under no circumstances shall the candidates be permitted to appear in the Trials without Original Educational marks Sheets/Passing Certificates & Documents mentioned above in paragraphs 29 (29.1) to (29.10). However, candidates with photocopies of Educational Marks Sheets/Passing Certificates may be permitted to appear in the Trials only on production of an ink signed certificate in original from College/School Principal certifying that Education Certificates/Marks sheets are deposited with College/School.

SELECTION PROCEDURE

- 30. The application format is given at the end of this advertisement. The selection procedure is as follows:-
 - 30.1 Application will be received only through post/ offline.
 - 30.2 Short-Listing criteria will be based on higher sports achievements.
 - 30.3 Call up letters to eligible short listed candidates will be sent through email, indicating date, time and place for selection trials.
 - 30.4 All original certificates and mark sheet are to be produced at the time of selection trial.
 - 30.5 Candidates declared Medically Temporary Unfit in the recruitment medical examination can avail specialist review from the specified Military hospital within a maximum period of 21 days. No further review/ appeal is permissible.

- 30.6 Candidates declared Medically Permanent Unfit in the recruitment medicals can appeal for Specialist opinion in a Military hospital within 21 days on payment of Rs. 10/- by Military Receivable Order (MRO) on Government Treasury (Medical Fitness certificate other than that of the specialist opinion in the designated Military Hospital will be considered). No further review/ appeal is permissible.
- 30.7 The select list will be prepared from the candidates who qualify in all respects depending upon the available vacancies in particular sports disciplines.
- 30.8 The candidature of candidates selected is valid for the current batch only.
- 30.9 All select listed candidates will submit Police Verification form alongwith the Offer of Enrolment and the candidates will be required to submit the same to respective regimental centre at the time of enrolment after getting their antecedents verified on this form from the concerned district police authorities. Candidates without police verification will not be eligible for enrolment.

33. Special Instructions

- 33.1 Candidates to produce birth certificate/10th class mark sheet at the time of preliminary document check.
- 33.2 Candidates are required to report at the Selection Trials Site by 0600 hours on their respective scheduled dates. Candidates reporting after 0600 hours without appropriate justification will not be permitted to participate in the Selection Trials. **Candidate should be clean shaven** (Except Sikh Candidate).

- 34.5 Certificates with overwriting and tempering of seals or erasing/alteration of any type will not be accepted.
