National Event- In a team event, sportsperson who have won medal (s) in National Games/ Senior National Championship/ National Open Championship or Youth/ Junior National Championship while representing any State/ UT/ Sports Control Board/ recognized federation held between 15/01/2024 to 15/01/2026 and conducted/ recognized by the National Sports Federation of concerned sports which are duly affiliated/ recognized by Indian Olympic Association (IOA)/ Ministry of Youth Affairs & Sports (MoYAS), Govt. of India (GOI).

#### Note:

- (i) Sportsperson should be the main playing member of the team and not in reserved list. He must have played/participated as playing member of the team in medal winning match/ competition. However, this condition does not apply to medal (s) won in International event.
- (ii) The list of Sports Federations affiliated/ recognized by Indian Olympic Association (IOA) and Ministry of Youth Affairs & Sports (MoYAS), Govt. of India (GOI) may be accessed from their official websites.

#### Note-

- Only Matriculation certificate shall be accepted as a proof for establishing age of the candidates.
- ii) The Candidates must fulfil all eligibility conditions and should be in possession of all certificates on the date of Recruitment. Candidates not in possession of education/sports certificates on the date of Recruitment shall not be eligible for recruitment.
- iii) All educational certificates other than Central Board/State Board shall be accompanied with Government notifications declaring the equivalence of such qualifications for service under Central Government.
- iv) The candidate has to upload copy of certificate or document on BSF recruitment website in support of his/ her highest medal/ position or highest level of participations in the advertised sports achievement for the advertised duration, else his/ her application will be rejected during scrutiny.
- a) Age & relaxations- 18 to 23 years as on 1st August, 2025.
  - Upper age limit is relaxable for SC/ST by five (5) years and for OBC Non Creamy layer (NCL) by three (3) years.
  - Note that only the Date of Birth as recorded in the Matriculation Certificate available on the date of submission of application will be accepted for determining the age and no subsequent request for its change will be considered or granted.

- iii) Candidate claiming age relaxation on basis of OBC (NCL) status may note that certificate on non-creamy layers status should have been obtained within one year before the closing date of online application.
- iv) Candidate who wish to seek age relaxation must submit requisite certificate from the competent authority, in the prescribed format when such certificate is sought by the Recruitment Board. - ii) A colour blind person shall not be eligible for recruitment. If a person is found to be colour blind at any stage of service career, he/she shall be boarded out as per SHAPE policy in vogue.

### 7. Selection Process-

Online application forms and copy of certificate uploaded by the candidates will be scrutinized and if found in order the candidates securing minimum qualifying 12 marks (for all category UR/SC/ST/OBC) and as per para 4b(iii) will be issued online admit cards to appear in the recruitment process i.e. Physical verification of Documents, Physical Standard Test (PST), and Detailed Medical Examination by the Recruiting Agency. Candidate will have to undergo the following process of recruitment-

#### (i) Documentation-

Original documents will be returned. BSF at its discretion can check or verify genuineness of any document/certificate produced by the candidate during recruitment and the decision of BSF after such verification/checking shall be final.
- e) Players who have participated or won medal(s) in the competitions given at para 4(b) above during the period from 15/01/2024 to 15/01/2026 shall be eligible for recruitment to the post of Constable / GD (Sportsperson) in BSF.
- f) Candidates will be given marks for medals won or level of participation during aforementioned time period only.
- g) Only the marks of that one higher medal/position or level of participation in which a candidate is getting maximum marks as per table given at Para 4(b) will be considered.
- h) If any candidate has secured more than 1 medal in a particular competition, in that case he/she shall be awarded marks for (only one) highest medal/position secured in the competition.
- i) Candidates who are unable to produce the prescribed certificate/documents will be rejected summarily and candidates who are declared qualified at documentation stage will be sent for Physical Standard Test (PST).



- j) OBC (NCL) certificate as per Annexure- IV, Scheduled Caste (SC)/ Scheduled Tribe (ST) certificate as per Annexure -III. Certificates obtained in any other format will not be accepted. Candidates claiming OBC status may note that certificate on Non Creamy Layers status as per Annexure-IV(A) should have been obtained within one year before the closing date of the online application.
- k) Candidates seeking relaxation as OBC (NCL) shall submit a declaration as Annexure-IV(A).
- Persons serving in Government services applying for the post are required to furnish No Objection Certificate (N.O.C.), as per Annexure-II issued by their employer at the time of physical verification of documents. Candidates who fail to submit No Objection Certificate (NO.C.) at the time of documentation shall be summarily rejected.
- m) Certificate as per Annexure 'V' for claiming relaxation in height & chest (if applicable).
- n) Domicile Certificate issued by local revenue authorities or PAN Card or Aadhar Card or Driving License or Voter ID Card or Passport for verification of citizenship. In case of West Pakistani Refugees settled in UT of Jammu & Kashmir and UT of Ladakh, they are required to produce Certificate in the format attached as Annexure- V issued by the Sarpanch/ Numbardar of a candidate's village to the effect that the person belongs to the West Pakistani Refugees category, along with a copy of Electoral Roll showing the name of the candidate in the voter list for elections to the parliamentary constituency.
- Four latest passport size photographs same as uploaded with online application form, to be submitted during documentation.

# (ii) Physical Standard Test (PST):-

- a) Candidates who qualify in documentation will undergo PST as per the standard mentioned at Para 4(c) above.
- b) Candidate seeking relaxation in height and chest will be required to submit the certificate as per Annexure-V regarding their community from concerned District Authorities. In the event of non-enclosure of the certificate, their claim for relaxation in height and chest shall not be entertained.
- c) Those candidates who do not meet the required physical measurement at PST or DME stage will be eliminated from the recruitment process.
- d) On reporting of female candidates for Physical Standard Test (PST), a selfdeclaration indicating about her pregnancy status shall be submitted. In case, if she declares that she is not pregnant then, she will be allowed to participate in the PST. In case of false declaration, all the risk for undergoing PST will be of her own.
- e) If the female candidate declares that she is pregnant before PST, then a confirmatory pregnancy test is to be done and in case she is found to be pregnant, irrespective of duration of pregnancy, she will be declared temporary unfit and her appointment shall be held in abeyance until the confinement period is over. She will be re-examined for PST six weeks after the date of confinement, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she is found fit, she will be



appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instructions of the Government, as amended from time to time. In case female candidates is found negative for pregnancy, she will be allowed to participate in the PST. However, female candidates who is declared temporary unfit have to appear and qualify PST and DME/RME and have to secure place in final selection list of respective discipline/event.

### (iii) Merit List-

- a) After completion of Documentation process and Physical Standard Test, Merit List will be drawn on the basis of marks obtained by the candidate as per table given at Para 4(b) (III) in the advertised sports disciplines.
- b) The candidate shall be shortlisted for Detailed Medical Examination (DME) on the basis of merit. Tie will be resolved as under
  - i) Candidate securing highest marks will be placed higher in the merit list.
  - ii) If the candidate appearing for the recruitment having similar achievements in International competition than achievement in National competition will be considered for breaking tie (candidate with higher achievement in the National competition will be placed higher in merit).

(iv) Detailed Medical Examination (DME): Candidates selected in order of merit as per number of vacancies will be put through DME to assess their fitness as per the medical quidelines issued from time to time by MHA.

# (v) Appeal against Detailed Medical Examination: -

a) A candidate declared unfit in detailed medical examinations, if not satisfied with the findings of the Medical Officers, can submit an appeal for his/ her re-medical examination along with a Medical Fitness Certificate as per Annexure-'VI', as a piece of evidence about the possibility of an error of judgment in the decisions of the Medical Officer.

- b) The medical certificate will not be taken into consideration unless it contains a note by the medical practitioner concerned to the effect that it has been given in full knowledge of the fact that the candidate has already been rejected as unfit for appointment by a Medical Officer.
- c) The appeal will also not be taken into consideration unless it contains Medical Re-Examination fee of Rs. 25/- through Indian Postal Order in the name of Recruiting Agency and rejection slip (in original) issued by the Presiding Officers.
- d) The appeal should be submitted within 24 hrs from the issue of the Rejection Slip (in which the finding of the Medical Officer is communicated to the candidate) to RA. The appeal received after prescribed 24 hrs or without relevant documents will not be entertained.
- e) The candidate who have been declared unfit in Detailed Medical Examination will be briefed about the procedure for submitting appeal for re-medical examination at the venue.
- f) The decision of BSF Medical Board shall be final for declaring a candidate Fit or Unfit in RME.
- g) There will be no second RME appeal for candidate declared unfit in DME.
