This is for information to all concerned that the Written Test (OMR based MCQ type) under the **Regular Mazdoor Recruitment Examination**, 2025 (Advertisement No. PHC/01/2025) was held on 22.06.2025 (Sunday) in single shift at various examination centres situated in PATNA. The Model Answer of all the series of Question Booklet i.e. A, B, C & D of the Written Test are being published herewith as <u>Annexure-I</u>.

A candidate, who has appeared in this examination and wishes to raise an objection regarding any question and/or the Model Answer may submit an online request through the link available on the official website of the High Court i.e. <u>https://patnahighcourt.gov.in</u> from 21.07.2025 to 27.07.2025 (up to 11:59 P.M.). The objection must be supported by a copy of authentic source document(s)/proof on the basis of which it is being submitted.

Candidates shall be required to pay a non-refundable fee of 350/- (Rupees Fifty only) per objection raised, through online mode. Only those objections submitted within the stipulated time, in the prescribed manner, and accompanied by the requisite fee shall be considered.

The Model Answer shall be finalized after considering the valid objections received within the prescribed time, which shall be used for generating the result of the Regular Mazdoor Recruitment Examination, 2025. No representation regarding any question or the final Model Answer shall be entertained after the closing date for submission of objections and any such representation shall stand rejected without assigning any reason. In the event of non-receipt of any objection, the Model Answer published herewith shall be deemed final and the result shall be generated accordingly.

The decision of the High Court of Judicature at Patna on the objections shall be final and no further correspondence shall be entertained in this regard.
